6	Panel Discussion: What Infrastructure Contributions mean for stakeholders On 1 January 2022, the NSW Government rescinded a previous (2008) decision to set water, wastewater and stormwater infrastructure contributions to zero. The Government's decision followed a public review by the NSW Productivity Commission, which found that the benefits of removing the zero charge policy would outweigh the costs. In practice, the policy change will affect different stakeholders in different ways, and this will influence perceptions about the merits of the change. The outcome experienced by different stakeholders is also very dependent on a calculation method set by the pricing regulator IPART, including how Sydney Water implements any discretionary elements of IPART's method. To assist CCRG members in understanding the range of views related to this issue, we have invited a number of our members to present their understanding, and what the mechanism might mean for their stakeholders Sydney Water have also been invited to present. Each panel member will have a short time to present their view, following which opportunity will be provided for Q&A across the group. The outcome is anticipated to be an enhanced understanding of a complex issue from a number of standpoints, which we will capture for future reference as discussion around Infrastructure Contributions evolves.
