#### RiverWatch™

RiverWatch<sup>™</sup> is Sydney Water's recreational water-quality monitoring and reporting program, developed to support the opening and operation of swim sites. We can provide in-house sampling, analysis and reporting of water-quality data and help councils select a package of water-quality monitoring based on their specific site.

Sydney Water has partnered with the University of NSW to develop a predictive water-quality model to enable daily forecasting of water quality based on local conditions. The model can be adapted to new swimming sites as they come online.


We are also trialing new in-situ, real-time waterquality monitoring technologies to speed up initial sample collection and simplify ongoing monitoring and reporting.

The RiverWatch<sup>™</sup> service can complement or replace existing water quality monitoring carried out by council or their contractors. Sydney Water monitoring and reporting has the benefit of consistency across all sites and over time. Sydney Water's well-resourced labs are accredited by the National Association of Testing Authorities (NATA) and operate year-round.
