The Department notes the Proponent’s intention to stage erosion and sediment control measures on the AWRC site, in line with the Project’s Environment Protection License (EPL) application. As per your commitments within Appendix C of the Construction Surface Water and Groundwater sub-plan, water captured on site during Phase 1 construction activities (prior to discharge being permitted under an EPL) is not permitted to be discharged from the AWRC site. During Phase 1, construction activities must be stopped when the onsite detention (OSD) basin reaches 85% capacity and the site stabilised with a C-factor of less than 0.6. Construction may not recommence until the OSD is restored to at least 85% capacity.

Phase 2 construction activities are not permitted to commence on the AWRC site until further detailed erosion and sediment control plans (ESCPs) outlining future construction phases are prepared and submitted to the Department and EHG for information. Commencement of Phase 2 construction activities are subject to an EPL variation permitting licensed discharges of water from the AWRC site during construction being issued by the EPA.

The Department notes this approval is subject to the Commonwealth Department of Climate Change, Energy, the Environment and Water (DCCEEW) approval of the CEMP, Construction Biodiversity sub-plan, and Construction Heritage sub-plan under condition 7 of EPBC 2020/8816. Please provide the Department a copy of any approval issued by the Commonwealth.

If there are any inconsistencies between the approved documents and the conditions of approval, the conditions prevail. Please ensure that you make the approved documents and this approval letter publicly available on the project website.
